

2025 Contest Format: 4 Judges 3 Divisions 30 Entries Entry Fees 4 Places Paid

Judging: Judges Panel is comprised of 1 local government official, 1 representative from a sponsor of the event, 1 representative from a BBQ company and a Celebrity Chef or Food Critic. Judges will sample entries from contestants from 10 am until 2 pm on Saturday June 14th, 2025. Late samples from the contestants will not be accepted. The judges will examine each entry from all divisions and score each box from 1 to 10 on color, aroma, taste, tenderness and overall impression. The highest total combined score in each division will determine places from honorable mention, 3rd, 2nd and 1st Place. In the event of a tie, decision will be made by highest score from the celebrity chef's score card, if still tied by BBQ company Rep.

Divisions:There are 3 divisions for the contest, which are Brisket, Chicken and RibsEntries:Entries shall be limited to 30 in each division contestants may enter all 3 divisionsEntry Fees:The entry fee to each individual division is Fifty Dollars (\$50)Awards:4 places paid in each division are honorable mention, 3rd, 2nd and 1st Place

- Certificate of accomplishment for 4 places (certificates will be mailed to winners after event)
- Trophies for 1st, 2nd and 3rd Place (Individual name engraving done on site or paid for)
- Prepaid gift cards valued by place \$100, \$150, \$350 and \$750 for 1st Place

- 1. Application deadline is June 1st, 2025. You will receive confirmation of your location
- 2. No late entries will be accepted, notification of receipt of entry is only official entry, if you have not received official notification of receipt before deadline, it's your responsibility to confirm receipt
- 3. Confirmations of your entry will be sent via email, regular mail, text or phone call
- 4. This is a rain or shine festival. There are no rain dates. There are no refunds
- 5. The sale of BBQ, food or other items requires the purchase of a Vendor Spot
- 6. Event Management reserves the right to prohibit the sale of any item
- 7. Set-up time and cooking for contestants starts at 8 am on Friday June 13th, 2025
- 8. Check-in at 2195 Jaycee Wy, Huntsville, AL 35801 with BBQ contest official
- 9. Contestant parking will be assigned at check-in
- 10. Absolutely no foul language, inappropriate dress, behavior or conduct shall be tolerated determinations and consequences of offenses by Event Management
- 11. Trash collection & removal are contestants responsibility and are to be emptied regularly
