Those nominated must be Fathers - Biological, Mentors, Grandfathers, Adoptive or Foster Fathers. Entries must discuss the nominated Father's community service, participation in family activities, charitable work and, if applicable, any other activities that he participates in. Entries must be typed, double-spaced or printed legibly. Video submissions are accepted.

Essays entered will be judged by a panel of 4 independent persons, comprised of local government leaders and event sponsors. Judges will review and score submissions on a scale of 1 – 10 on factors such as charitable work the nominated Father does, his impact on his family, the impact his service has on his community or society generally, other activities in which he engages and overall impression of story. The highest average of the total combined scores in each area will determine places from honorable mention, 3rd, 2nd and 1st Place. In the event of a tie, winner will be determined by highest score of the overall impression of story, if still tied by an Epic-Live-Events company Representative.

Awards: 4 places paid are honorable mention, 3rd, 2nd and 1st Place

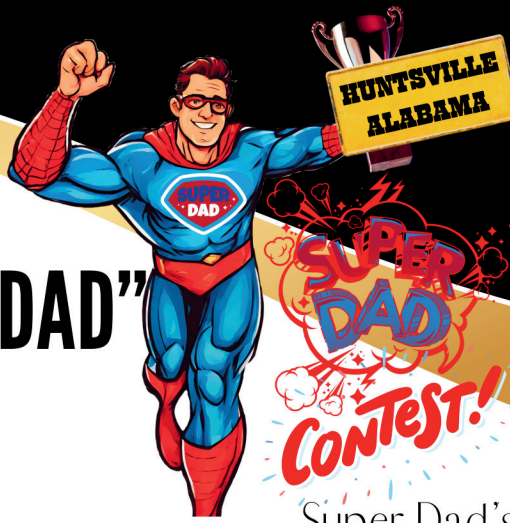
